Indiana Firefighters PAC Achievements

- Expanded firefighter residency
- Heart, Lung, Cancer, and Parkinson’s presumption legislation
- Deferred Retirement Option Plan (DROP)
- Law change to allow widows of the 1937 plan to remarry without losing pension
- LODD Benefits
 - \$150,000 death benefit
 - Paid health insurance to spouse and dependents
 - Free in-state college tuition to minor dependents
- Starting and maintaining the 1977 pension fund with continued oversight
- Meet and confer law
- Municipal EMS job rights
 - \$150,000 death benefit for municipal EMS LODD
 - Gained ability for Municipal EMS to purchase long-term and short-term disability
- Federal tax exemption for line of duty disability pensions
- Paid medical for firefighters hurt on duty
- 100% pension relief to local units for 1937 pension fund
- Firefighter Safety Notification law
